



## CONDITIONS FOR CONSULTATION AND REPRODUCTION OF ARCHIVE DOCUMENTS AND AUDIOVISUAL TESTIMONIES ARCHIVED AT THE AUSCHWITZ FOUNDATION

### RULES

#### 1. *Conditions for the consultation of documents :*

Any consultation is subject to a personal authorization delivered by the Auschwitz Foundation. For students and researchers, authorization may only be delivered on the basis of a request in writing by the Director of the research specifying the scope and the subject matter of the research and its objective.

The Auschwitz Foundation reserves to itself the right to grant or not to grant the authorization to consult archive documents that he keeps.

#### 2. *Conditions for the use and reproduction of documents :*

- Any use, in part or in whole, of the text, sound and images must conform to the respect due to the memory of the survivor(s) and to the remembrance of the deportation.
- Any use, in part or in whole of the text, sound and images must respect copyright and the individual rights of third parties. If these rights are not respect, only the person making the request shall be held liable.
- Any use, in part or in whole of the text, sound and images must necessarily cite the following: Archives de la Fondation Auschwitz [Archives of the Auschwitz Foundation].
- Any reproduction in part or in whole, of the text, sound and images is at the discretion of the Auschwitz Foundation and is subject to a personal authorization delivered by the Auschwitz Foundation. For students and researchers authorization may only be delivered on the basis of a request in writing by the Director of the research specifying the scope and subject matter of the research and its objective. The Auschwitz Foundation reserves to itself the right to grant or not to grant the authorization to reproduce archive documents it keeps.
- The names and first names of witnesses of Archival material of audiovisual testimonies of survivors of Nazi concentration and extermination camps mpay in no case be reproduced. It is recommended to use fictitious names with an indication of the archive reference of the Auschwitz Foundation.
- The reproduction authorized by the Auschwitz Foundation may in no case be reproduced nor communicated to a third party without prior personal authorization of the Auschwitz Fondation.
- The Auschwitz Foundation reserves to itself the right to delete the names of private persons on reproduction of documents that it keeps.
- Any reproduction requires that de person requesting lodges a copy of each use which has been made of the authorized reproduction(s).

#### 3. *Warning:*

By way of precaution, interviews with survivors, as registered by us at the Auschwitz Foundation are not intended neither by their form or content for a public use or dissemination. Their objective is both for scientific research and teaching purposes.
